HACC PRESENTATION AND JUDGING DAY SET FOR NOV. 16

The final presentations and judging for the 9th Hawai'i Annual Code Challenge (HACC) will be held on Saturday, November 16 at the University of Hawai'i West Oahu starting at 10 a.m.

Departing UH President David Lassner will be the featured speaker.

More than 140 high school and college students and young professionals have formed teams to solve six specific code challenges submitted by government, nonprofit, educational and technology groups.

The teams will present their challenge solutions as they compete for first place prizes

of \$3,000 in three categories, \$2,000 for second place and \$1,000 for third place.

For the first time a "Meet and Connect Expo" will be held to bring together technology companies and government departments with young people at the beginning of their careers in IT.
